The role of Enterprise Legal Counsel will be a key position within the Group Enterprise Legal department, within the Düsseldorf office (Germany).

The purpose of the role is to support Vodafone's Group Enterprise business by providing expert legal advice on commercial and contractual matters to all areas of Group Enterprise including VGE, M2M, Cloud and Hosting and Carrier. You will start in this position for a limited period of one year and two months with the option of a prolongation.

As Enterprise Legal Counsel your main responsibilities will involve:

- Drafting and negotiating significant /complex contracts and other legal documents within telecommunications relating to deals with major multinational companies and carriers arising through the operations of the Group Enterprise businesses operating in the Region.
- Providing accurate, effective and timely legal advice, analysis and support on commercial and contractual matters relating to the Group Enterprise businesses (VGE, VCS, M2M and HCS) operating in the Region.
- Identifying areas of risk for Vodafone in relation to commercial and contractual legal issues affecting Group Enterprise businesses and assisting in providing solutions to manage the risks.
- Maintaining effective contact with relevant individuals in other key functions outside Group Enterprise Legal, such as Regulatory professionals in the Public Policy teams, Group Technology, Tax, etc. Influencing and assisting in discussions to ensure the best legal solution to meet commercial objectives.
- Assisting in the development of best practice within Vodafone regarding the legal aspects of commercial and contractual matters, reference product development and deployment
